Work Party: As we did 3 years ago, we will pressure-wash the fence on one weekend and paint during the work party. Block Watch: Jeff will advertise Larry's block watch effort in the newsletter.

Walk-Around Committee: Larry will contact new volunteers Paul C and Patricia V, and previous committee members Tari F and Bethany K, to see if one of them is willing to lead this committee. The committee will look for violations and report them in writing to the board. This is intended to remove the burden of telling on one's neighbor.

Request for "Impartial 3rd Party" Property Manager: Larry will ask Ted C to get bids from three property management firms.

Complaint Process: Jeff will think about how to streamline the complaint process while complying with our governing documents.

Higher Dues for Rentals: Is it legal? **Lori** will read our governing documents and the RCWs.

Landscaper Bids: Morten will start looking for landscapers who might want to bid on our common area maintenance. Melodie has already found one. We will ask our current landscaper Joaquin V to bid.

Garage Sale Spring 2016: We will revisit this in Jan/Feb/Mar.

Streetlight at Trailhead: The trail is open from dawn to dusk, so City of Milton will likely have no interest in installing a streetlight. **Morten** will contact Puget Sound Energy about installing one like Susan K did a couple years ago. **Lori** will send our current PSE account numbers to Morten.

Fireworks Fire in Park: Jeff will mention in the newsletter that fireworks are prohibited in the park (just like the sign says). We may ask for volunteers to patrol the park next year.

Enforcements:

• Lot 88 corvette under orange tarp: Jeff will write a complaint, which will start due process. If we apply a \$150 fine, we can put a lien on the property.
