One of the items discussed at the annual HOA meeting was our landscaping contract. After talking with and receiving quotes from a number of landscapers, the board has selected a new landscaper and entered into a month-to-month contract. The monthly cost is the same as what the previous landscaper was being paid, though the new contract more clearly stipulates duties and

expectations. The new landscaper starts in August; so don't be surprised if you see some new faces caring for the park and common areas.
